These gaps identify the necessity for pharmacy stakeholders such as the provincial pharmacy advocacy organizations to assume a better advocacy role with respect to the development of pharmacy practice. Pharmacy has an established evidence base that supports the health and cost benefits of pharmacist activities in many settings, including community, primary care team, long-term care and hospital settings. For example, medication reviews have been shown to be useful in improving the management of diabetes or hypertension, overall appropriateness of medications prescribed and medication discrepancies, but they show mixed effects for other outcomes. Hospital pharmacist medication review reduces hospital readmission and reduces length of hospital stay. Community pharmacist-based targeted interventions, including those for cardiovascular care, renal disease, dyslipidemia, smoking cessation and diabetes care, improve outcomes for people with chronic diseases. Highlighting opportunities for the profession of pharmacy to contribute to quality medication management can increase the potential of Canada’s 42,500 pharmacists (the third largest health care profession after nurses and physicians), who remain an incredibly underused health resource.

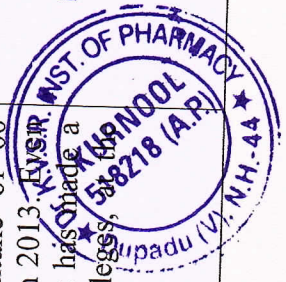

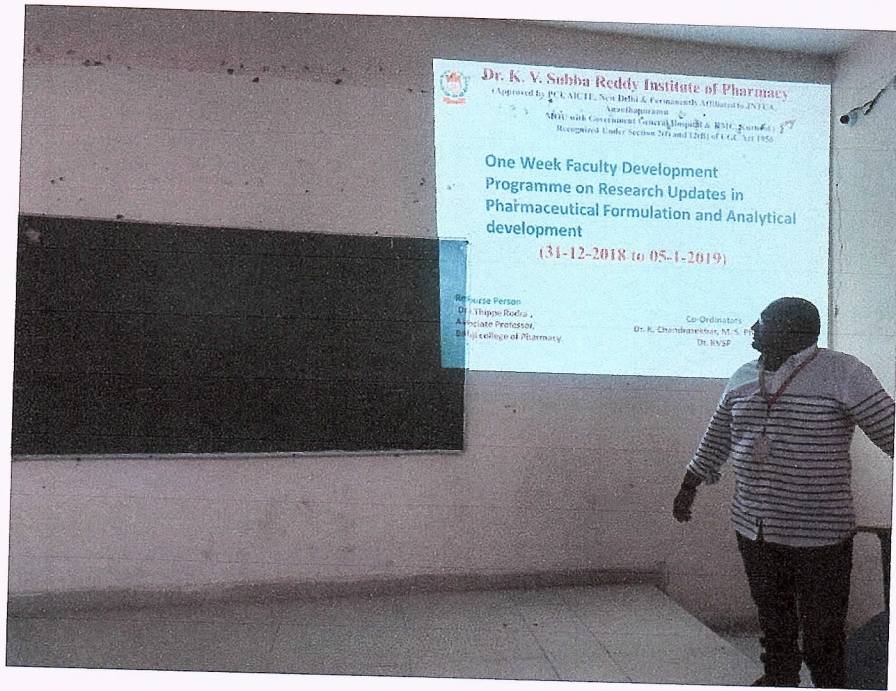

Two significant challenges of resilience analysis are to (1) quantify the resilience associated with a given recovery curve; and (2) develop a rigorous mathematical model of the recovery process. To quantify resilience, a mathematical approach is proposed that systematically describes the recovery curve in terms of partial descriptors, called resilience metrics. The proposed resilience metrics have simple and clear interpretations, and their definitions are general so that they can characterize the resilience associated with any recovery curve. This paper also introduces a reliability-based definition of damage levels which is well-suited for probabilistic resilience analysis. For the recovery modeling, a stochastic formulation is proposed that models the impact of recovery activities and potential disrupting shocks, which could happen during the recovery, on the system state. For illustration, the proposed formulation is used for the resilience analysis of a reinforced concrete (RC) bridge repaired with fiber-reinforced polymer. He also explained the act of discovering and delivering new medicinal drugs, devices and therapies.

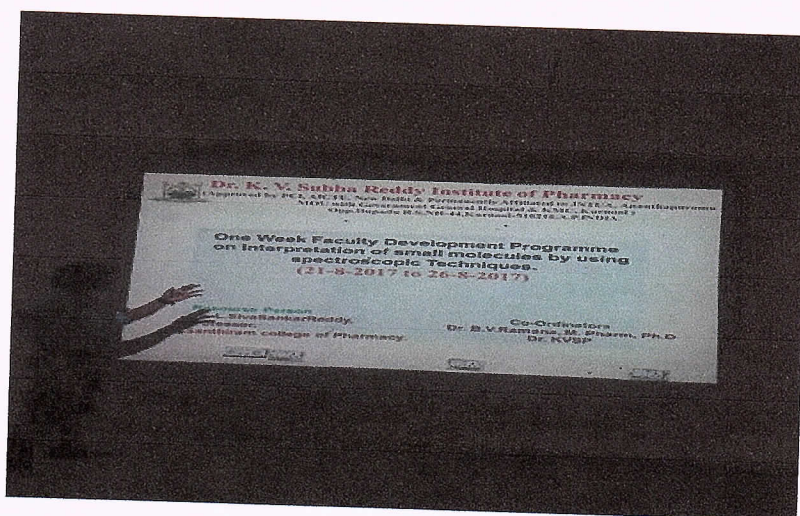

**Description:** A six-day faculty development Programme was organized by Dr.K.V. SUBBA REDDY INSTITUTE OF PHARMACY, DUPADU, KURNOOL, with the theme "FDP ON INTERPRETATION OF SMALL MOLECULES BY USING SPECTROSCOPIC TECHNIQUES" from 21-8-2017 TO 26-8-2017. The speaker enlightened on how to Interpret Small Molecules By Using Spectroscopic Techniques and also shed light regarding the obtained results indicated that metal oxide and diamond NPs exhibited high LDI efficiency in the positive ion mode, resulting from the good laser absorption efficiency at 355 nm and low thermal conductivity. This whole process is thermally driven, largely independent on the analytes because cationization process begins to occur after gasification of analytes, showing high specificity. Moreover, other NPs showed good specificity both in the positive and negative ion modes, due to the specific affinity of the analytes on the NPs. Therefore, besides chemical interaction, thermal driven desorption plays a significant role in nanomaterial-assisted LDI using the metal oxides NPs.
