**ORDER:**

1. The “Dr.K.V.Subba Reddy Institute of Pharmacy, Opp.Dupadu R.S, Allagadda Post, Kurnool Dist” was given Temporary affiliation for running Degree courses during the academic year 2015-16 vide Procs.(1) read above.
2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2016-17 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2016-17 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2016-17. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2016-17 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 28-11-2016.

1. The College should apply for NBA& NAAC accreditation
2. At least two governing body meetings are to be conducted in a academic year
3. Computer to Student ratio is to be maintained as per AICTE norms
4. Internet speed of 48 MBPS should be available as per norms
5. At least 10 legal application softwares to be procured with adequate number of licenses
6. Fuming cupboards to be replaced with new ones
7. Software for ACS (English) lab to be procured
8. Library automation software to be procured
9. e-journals prescribed by AICTE to be procured



10. Digital library has to be established
11. e-learning resources to be procured
12. Location and ambience of the Examination branch congenial for carrying out confidential work
13. Biometric system of attendance is to be adopted for all UG&PG students and staff (teaching & non-teaching)
14. CC cameras are to be installed in all the class rooms, Exam halls, corridors, vantage points, library & canteen
15. Faculty cadre ratio is to be maintained as per norms
16. Faculty student ratio has to be maintained as per norms for B.Pharmacy course
17. Atleast 50% of faculty appointments have to be ratified by the University.
18. Internal marks are being given liberally.
19. NSS Unit has to be established
20. Aadhaar and PAN number has to be obtained by all the teaching staff

3. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant **Temporary Affiliation** to "Dr.K.V.Subba Reddy Institute of Pharmacy, Opp.Dupadu R.S, Allagadda Post, Kurnool Dist" sponsored by "Vaibhav Educational Society, Flat No.203, Alankar Plaza, Park Road, Kurnool Dist" to offer the following courses with the intake shown against each for the Academic Year 2016-2017 as detailed below:
